We would like to express our deepest sympathies and condolences to those who lost by the new coronavirus, and we sincerely sympathize with the affected people and pray for their early recovery. We would also like to express our deep gratitude to all healthcare professionals and everyone who is making efforts in the forefront of preventing infectious diseases.

While the pandemic due to the new coronavirus is not apparently converged, the Hosokawa Micron Group places the highest priority on ensuring the safety and health of employees, their families, business partners, local communities, and other stakeholders. We are taking measures to control the spread of infection according to the guidelines and requests of the local government.

We would like to inform the current status and impact of COVID-19 as of today as follows,

1. Current Status and Action of Hosokawa Micron Corporation and Overseas Group

(1) Hosokawa Micron Corporation

We have established a company policy for infection control in accordance with the government guidelines and the guidance of each local government, and are working to ensure that all employees are fully informed. In accordance with our company policy, administrative employees are working from home mainly, and manufacturing and related employees are working at the factory with avoiding the “Three C’s” those are Closed spaces, Crowded places, Close-contact settings.

For commuting, the use of public transportation is prohibited in general and staggered working hour is recommended.

2. Impact on business

The impact of the new coronavirus is spreading all over the world, and while the prospect for settlement has not yet been seen, the governments of each country continue to prohibit or restrict travel, request to stay home, and economic and social activities are suppressed extensively. Under these circumstances, negative impact to our production activities due to lack of materials or parts has not been occurred but we have suffered some restrictions for sales promotion and order-taking activities. As the specific examples, our Italian customer closed factory, on-site work at customers were postponed due to restriction of transportation in domestic and worldwide.

It is difficult to estimate the entire scale and future impact on business because the period until the end of pandemic is uncertain. Our Group places the highest priority on ensuring the safety and health of employees and their families, and will continue to take the necessary measures to reduce the impact on business performance as much as possible.

The effect of this matter on the full-year consolidated financial forecast for the fiscal year ending September 2020 is currently under investigation and shall be notified as soon as we identified matters requiring disclosure.
